

Dear EGF representative,

This is the invoice for your annual membership fee.

In the 2021 AGM a new membership system has been accepted. We changed to a system of a fixed fee per active player stronger than 10 kyu (EGD rating 1050) who played at least one tournament within the last 3 years (2021-2023). The minimum fee is € 50.

In the 2023 AGM it was decided that the fee per active player is now € 5,00.

As there was a delay in producing the invoices the deadline for payment of this invoice is 15 April 2024. After this date we are authorized by the AGM to impose a late payment fee of 20%.

And one reminder for some members: Please check in your administration if you have any payments to the EGF due over previous years, including Bonus Point Tournament Fees. I will send separate emails to those members soon.

#### IGF membership fee

In the past, you could include the IGF membership fee with your payment. However, due to a change in the IGF presidency, there is a delay in their invoicing. They will send the 2023 invoices in April 2024 to countries that have not paid 2022 and 2023 fees. I advise to wait for their invoices before paying. If you still want to add the usual annual fee, include it with the EGF membership fee. Overpayments will be deducted from next year's membership by the IGF. We will consolidate all IGF payments and transfer them later this year. Please add a bit extra (around 2 €) to cover exchange rate fluctuations and transfer fees to Japan.

If you cannot make the transfer then please contact me about other possible ways of making the payment, a bank transfer is the preferred method though. If the transfer rates are high, you can also check if you can make cheaper transfers by the website wise.com, but this service is not available in all countries.

Please remember: This membership payments should be made before 15 April 2024! If you fail to do so, you will be charged 20% penalty fee.
